

BRIEF HISTORY OF THE MT. HEBRON BAPTIST CHURCH

The Mt. Hebron Baptist Church under the name of the Mt. Hebron Baptist Church of Christ was organized in 1832 as far as the records exist. The church celebrated its hundreth anniversary in 1932.

The first building to hold the services was of log quality. This church was torn down in 1852 to be rebuilt by another one. In 1916 another church was built. The records from 1832 to 1852 were destroyed by fire. In 1852, the first meeting of the new church was held on the first Saturday in April with Bro. Elisha Cobb as pastor.

In July, 1854, the 3rd Saturday, the church met to send messengers to the first Concord Association. The messengers elected were Andrew Gross, G. G. Gross, and William Chapman.

In 1867 Mt. Hebron Church had 73 new members enrolled. The first Sunday School was in 1879.

In 1880 Mt. Hebron Church helped to organize the Holbrook Church by granting 35 members their letters and Bro. J. W. Lee. Also in 1882 a committee to help organize a church at Crossroads in Grant County was appointed.

In the year of August, 1954 Bro. Lorn White and his family left to do missionary work in Hawaii.

On August 7, 1949, new lights were put into the church. On October 1953, repairs on ceiling and walls were made. In August 1963 the church was painted on the outside. In April 1964-65 repairs were made on the church by lowing the ceiling and putting on new storm windows.

In the record book we have the following rules of the church in 1852.

"RULES OF DECORUM FOR THE CHURCH"

- 1. For a Moderator to be chosen by order of the church.
- Any member that speaks or makes a proposition must first arise and address the Moderator in a Brotherly Christian-like manner.
- No member shall speak more than thrice on any matter without lieve of the Moderator.
- No more than one shall speak at a time and shall make no remarks on the slips or mistakes of his Brother that speaks before him.
- 5. There shall be no laughing while on business.
- 6. No member shall leave his seat while on business without lieve of the Moderator.
- 7. The Moderator shall call to order when any of these rules are violated, but any person so called to order shall have the voice of the Church if he chooses, and all public transactions may be brought before the church without asking the same steps as with private offenders.
- All business shall be done by a majority except in receiving members which shall be done by a unaminous voice.
- 9. Neither the accuser nor the accused shall be allowed the privilige of a vote and the dicision of any matter when the difficulty arises between two when each is distrubed one with another.
